Deputy Commissioner of Finance Elizabeth Janocha, presented a brief financial update. Budget Director John Jacobson reviewed the budget status report as of September 6, 2023 and The City of Yonkers Four Year Financial Plan. All budget transfers were reviewed by the Board and were recommended for approval at the September stated meeting. John Tobin & Brian Wiener from Tobin and Company provided a Summary of Monthly Claims Audit Reports for the period of February 1, 2023 - July 31, 2023. Discussions followed on budget projections over the next three years, the foundation aid regional cost index and Special Education expenditures.

At 5:21 p.m. the Board unanimously agreed to go into Executive Session to discuss a proposed settlement of a student due process matter.

On behalf of the Board of Education I would like to thank Ms. Lissette Colon-Collins, Ms. Cristina Jarufe, Mr. Chris Carvalho, and Mr. Brian Schulder. On October 3<sup>rd</sup> at 5:30 p.m., representatives from HYA will present the leadership profile report to the Board of Education and the public. This will take place at Saunders Trades and Technical High School, in the Angelo E. Paradiso auditorium.

#### - FROM THE SUPERINTENDENT 8.1 SUPERINTENDENT UPDATES

Communication from the Superintendent

Interim Superintendent Dr. Luis Rodriguez welcomed the school community to the 2023-2024 school year and provided the following updates:

- The district had a successful opening of schools and our students and staff were marvelous.
- The Superintendent attended the Lower Hudson Council of School Superintendent's inaugural meeting on September 15<sup>th</sup>. The key topics were a scholastic achievement dinner to provide scholarship aid to students in the Lower Hudson Valley area as well as a discussion with David Frank, assistant commissioner of the New York State Education department regarding the school district's responsibility or determining non-public schools within our borders meet substantial equivalency of instruction based upon applicable state regulations.
- The Superintendent and his executive team attended the Yonkers Council of PTA's Executive Meeting on Monday, September 18<sup>th</sup>. The meeting was quite informative and I addressed the group providing a report on the opening of schools as well as engaging in a dialogue regarding parent interests, concerns and priorities.
- On Tuesday, September 19<sup>th</sup>, the Superintendent hosted the first principal's meeting of the new school year. Topics of discussion included a review of assessment and attendance data as well as ELA and Mathematics performance data can more effectively be used to inform instruction to support students and promote teacher effectiveness.
- Earlier today, the City of Yonkers announced a partnership with Verra Mobility to launch the largest school bus safety program in Westchester County. The City of Yonkers SAFE STOP school bus safety program will be implemented this fall and is aimed at reducing accidents and injuries related to motorists who disregard the bus stop arm while children are boarding buses. Mayor Spano and the Superintendent will be filming a public service announcement, on Thursday, September 21st at the Enrico Fermi School at 9:30 a.m. regarding the program.
