Accordingly, we hereby request an extension of time of 180 days from March 5, 2025, to our contract completion date to take into consideration the noted delays listed above.

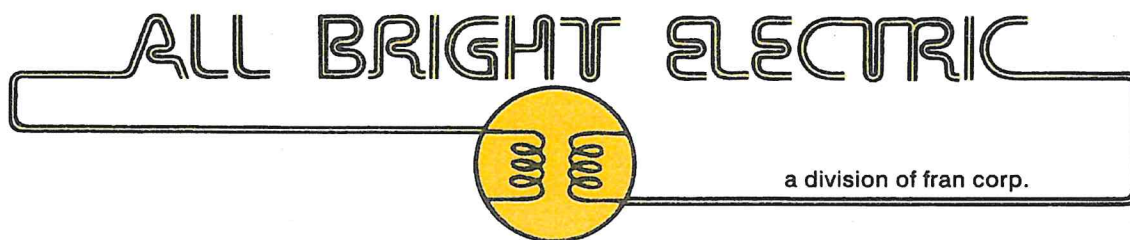
