Typical Coordinator Roles and Responsibilities

Daily Operations

- Identify and resolve daily safety and security concerns
Prompt management of emergencies
- Serve as a liaison with various county agencies (e.g. law enforcement, fire, and office of emergency management) for the coordination of security and emergency planning and management issues involving all schools

Security Personnel Operations

- Develop roles and responsibilities for district security officers in collaboration with Altaris and administration
- Assist the school during the hiring process of any new security personnel by conducting interviews and background verification
- Coordinate the duties of the security guards to ensure effective building and grounds security
- Review and revise officer deployment plans in collaboration with the Altaris consulting team and building administration
- Conduct regular planning and training meetings with security personnel and the Altaris consulting team
- Conduct random inspections of security officers at each school facility and report any deficiencies to the school liaison for an internal investigation
- Coordinate scheduling with the Athletic Director to ensure that all events are covered by the appropriate number of trained guards who are assigned and properly deployed

Emergency Response Team (ERT) Meetings

- Attend District and Building ERT meetings to review:
 - safety and security concerns of the team
 - current events that may impact schools
 - status of school-specific planning work being performed by Altaris
- Prepare a monthly summary report of all team meetings for review by Altaris and the District or School Safety Team
- Follow up on items discussed at meetings and work with department heads to resolve any issues that fall outside of the security department

Project Management

- Develop an annual action plan with goals and objectives in collaboration with administration and the Altaris consulting team
- Assist and collaborate with the Facilities and IT Directors, Building Administrators, and Contractors to implement safety and security upgrades including:
 - Technology
 - Capital projects
 - Equipment
- Collaborate with district and building-level administrators and Altaris Consultants to complete and continually update open emergency planning steps in the Altaris Project Portal
- Collaborate with emergency response agencies to conduct annual safety, security, and emergency preparedness assessments of all school and support facilities
- Complete an annual safety and security budget upon the request of administration
- Coordinate with the Business Office regarding inventory of security equipment and order replacements as needed (i.e. two-way radios, uniforms, etc.)
- Coordinate the development of detailed parent reunification:
 - Plans
 - Equipment
 - Training
 - Emergency service collaboration

Compliance

Drills and Evaluations

- Coordinate and manage a district-wide emergency drill schedule for all school buildings
- Coordinate attendance of emergency service personnel
- When possible, attend school emergency drills (lockdown, fire, etc.) to assist with execution as well as perform a formal evaluation and post-drill debrief with emergency team members
- Solicit feedback from building employees on the drill execution to identify gaps and loopholes

Emergency Plans

- Collaborate with Altaris to update and submit Emergency Plans including the:
 - District-wide Safety Plan
 - Building-level Emergency Response Plan(s)

Schedule Options to Suit any Budget

Altaris can provide Coordinators on a full-time or part-time basis to work within any school budget. While most districts utilize a full-time Coordinator for consistency in managing daily operations, some clients have opted for a part-time position that may be shared with a neighboring district. The shared position schedule can be flexible to allow the Coordinator to be on-site in each district for scheduled meetings, drills, or other events. Specific work hours are based on the needs of each district.

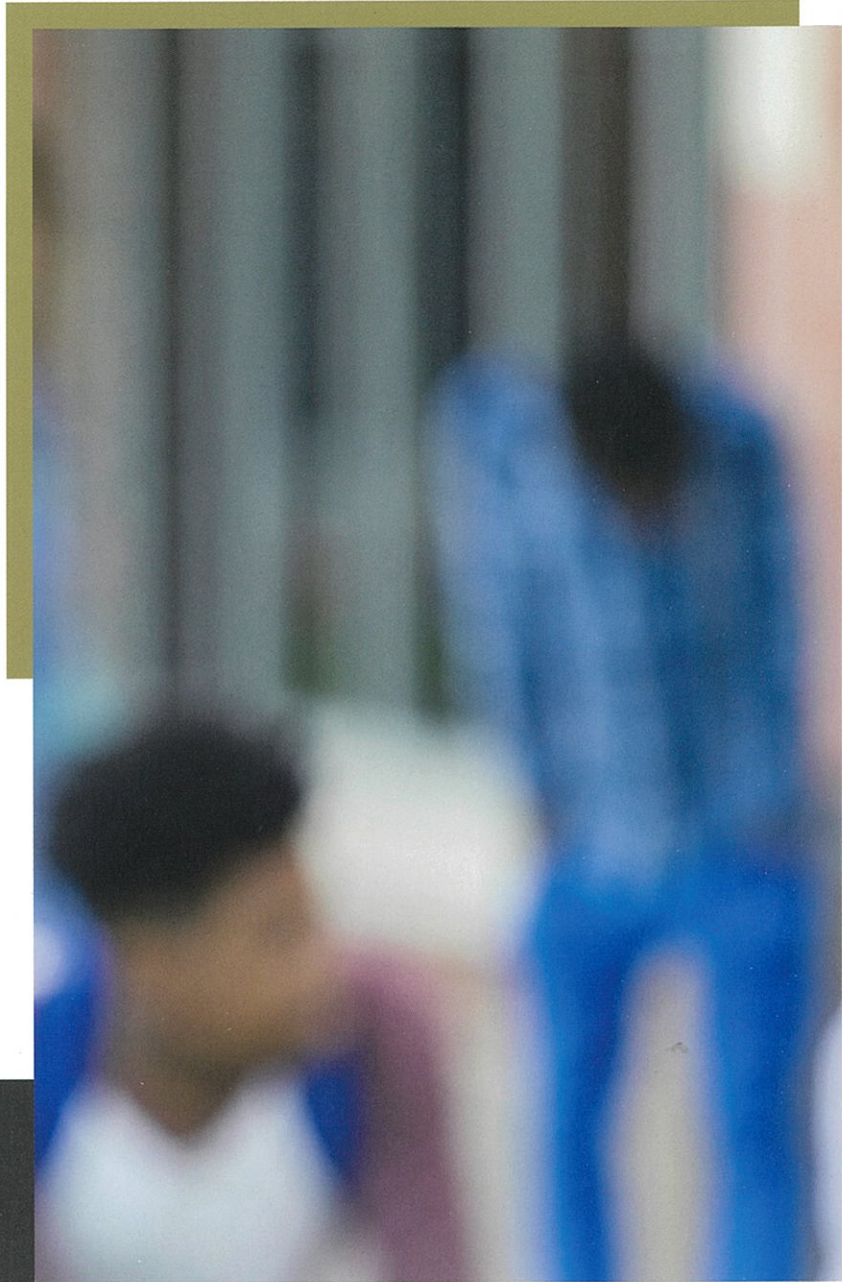
