This amendment is required to provide funding for work beyond the amended funding of \$2.5 million.

This is to provide funding for additional CIP's recently assigned to F&D such as School 32, School 29 Fermi, and Lincoln High. A tabulation of all assignments and fees to date is attached. Part of the assignments include construction administration and document closeout the completion of which will be as late as early 2023. The current contract expires on or about January 31, 2021 and shall be **Rationale:** extended to January 31, 2023.

The \$4.5 million dollar figure indicated above is an upper limit for expenditure under this agreement and will not be encumbered unless specific tasks are assigned, via Board resolutions.
