Rationale:

This is to provide uniform for the 265 custodians and maintenance workers in School Facilities Dept.

This includes 5 changes of shirts and pants supplied to each school on a weekly basis. Eleven of each are provided to allow for laundering. Each employees will have a clean uniform with no stains, tears or other problems for each work day. This is already in the CSEA contract. The union was involved in selecting these

services and has agreed to them.

This is essentially similar to the Cintas agreement with City DPW except that the District does not provide outdoor clothing. Procurement is through the purchasing cooperative Omnia

Partners R-BB-19002.
