

PERFORMANCE BASED CONTRACT GUIDELINES
CONTRACT AMENDMENT FOR STUDENT ASSISTANCE SERVICES (SAS)

1. WHAT IS THE PURPOSE AND SCOPE OF THE SERVICE? (Describe in detail any services to be provided or materials to be purchased)

This amendment, in service of Yonkers students in grades six through eight (middle school), focuses on increasing awareness of the dangers of using substances, especially those that may contain Fentanyl, other opioids, and/or other adulterants and contaminants, through a combination of information sharing, knowledge building, skills development and norms clarification. In addition, in furtherance of our District-wide efforts to increase Co-Occurring Disorders Awareness (CODA) and expertise, among our students and staff, a collaboration with The Harris Project Inc. will be established, to realize the objectives below.

Objective 1.

To provide information, education, and skill building to Yonkers middle school students using age appropriate in-person interactive classroom activities, and small group presentations from adult professionals, with corresponding printed and video materials, this includes CODA messaging, social emotional learning tools, and activities

Objective 2.

To use high school students as role models, to teach and practice refusal skills that reinforce messages to middle school students, through classroom role plays, presentations and after school programming, while ensuring that messaging reflects pathways to substance misuse/addiction, including mental health challenges and trauma

Objective 3.

To thereby identify high school students, particularly young men of color who demonstrate potential to be future educators, and refer them to other sources of District support, in furtherance of additional training/counseling in the field of education, they will also have specific presentations on the value and import of innovations in the field like CODA

Objective 4.

To provide relevant and interventional information to Yonkers parents of middle school students through in-person interactive presentations and demonstrations, with corresponding bilingual printed and video materials, including CODA. This collaboration will result in community and/or school-based prevention education presentations for families, community members, school administrators and staff, to increase engagement in mental health, trauma-informed, co-occurring capable services, including messaging on all substance misuse/addictions (vaping, marijuana, alcohol, mushrooms, cocaine, prescription medication, heroin and adulterants to the supply

Objective 5.

To create in-person and recorded presentations, on opioid abuse-related topics, for parents and students together and develop corresponding bilingual printed and video materials as described in Objective 4, above

Objective 6.

To develop frequent bilingual messaging for parents via social media, emails, postings on school websites, including age-appropriate CODA topics and themes with clearly identified school and community resources

Objective 7.

To create bilingual "Tip Sheets" for parents with suggestions for communicating with middle school youth, to promote healthy decision-making and to avoid behaviors like experimenting with the use of dangerous substances including CODA topics and themes designed to increase help-seeking behaviors

Objective 8.

To promote and reinforce the healthy norm of only taking pills, or using products, provided by parents/family members and/or health care providers by creating attractive posters to be displayed in highly visible locations in school buildings, reinforcing the messages, balanced with a recognition that youth who face mental health challenges and/or have experienced trauma often know these messages, but still turn to substances to self-medicate

2. AMOUNT OF SERVICE?

In terms of contractual services, funds will be used to pay adult education facilitators, teachers attending after hour programming and/or training and to provide stipends for high school student role models.

Non-contractual costs will include printing of materials, translation services, IT support for recordings of programs and messaging for different formats and platforms (e.g. phone versus Chrome Book, etc. A rate not to exceed 10% shall be allowed for program supervision/ agency administration of this amendment.

Students in all YPS District Middle Schools, and their parents will be served through different modalities; and staff will receive skills development workshops, as appropriate.

4. WHO WILL PROVIDE SERVICES?

Services will be primarily provided by SAS Counselors, and supplemented by trained high school role models who will receive a stipend, as appropriate.

SAS will both train and deploy some YPS high school students to serve as role models, under this initiative.

5. WHAT WILL BE COMMUNICATED TO DISTRICT PERSONNEL, PARENTS, OTHERS ABOUT PROGRESS AND RESULTS OF THE SERVICES?

(How specifically will the contractor report to the School District (or parents, if applicable) about their progress towards achieving the goals of the contract?)

The SAS Counselor in participating schools will provide the Principal a monthly statistical report on the number of referred students, services provided, contacts with parents, school staff and outside agencies and private practitioners.

6. HOW WILL THE SCHOOL DISTRICT JUDGE THE QUALITY OF SERVICES? (Set forth the method which will be used to evaluate contractor's performance)

The quality of services will be assessed by various measures, including: the number of students served, feedback from students, parents and school staff and by the attainment of the following results as reported by the students served:

- 80% increase perception of the risk of harm associated with substance abuse.
- 70% less approval of alcohol, tobacco, and other drug use.
- 60% reduce the consumption or maintain non-use of alcohol, tobacco, or drugs.
- 65% decrease associations with peers involved in delinquent behavior.
- 70% decrease participation in delinquent behavior.
- 65% increase their bonding with school.
- 30% have parents that participate in parenting programs, of which 80% will improve communication in talking with their children about alcohol, tobacco, or drugs.

The results will be measured by using questionnaires to document change in students' activities, perceptions and behaviors. The questionnaires will be completed by the SAS Counselor upon first meeting the student, and at the end of the school year.
