

PERFORMANCE BASED CONTRACT GUIDELINES

1. WHAT IS THE PURPOSE AND SCOPE OF THE SERVICE? (Describe in detail any services to be provided or materials to be purchased)

Interactive Health LLC will provide evaluation services pertaining to the *RECOVS: Recover for COVID School Program Learning Loss* grant program and the *RECOVS: Mental Health* grant program. Interactive Health, LLC will work with the RECOVS Grant Program Coordinator and the RECOVS Grant Program Facilitator using both quantitative and qualitative methods to assess the program's effectiveness in achieving its stated objectives. Services will include analyzing student academic outcome data; analyzing Panorama Parent and Student Survey data; creating and administering surveys specifically designed to measure professionals' self-reported ability to identify and respond to learning loss; tracking student engagement with Learning Loss Coaches; tracking the use of the Learning Loss Centers for peer tutoring and other recovery interventions; gathering qualitative feedback from students, teachers, Learning Loss Coaches, and parents to gain insights into the program's effectiveness and areas for improvement; and developing comprehensive reports detailing the findings to make informed decisions to enhance its support for students and professionals.

2. AMOUNT OF SERVICE?

Interactive Health will provide 50 days to analyze assessment data (25 days per grant); administer and analyze surveys; report on the fidelity of the interventions; analyze data collected from participation feedback forms that will be administered to students, teachers, Learning Loss Coaches, and parents; collect relevant district data; and assist in meeting all semi-annual and annual NYSED reporting and monitoring requirements, including reporting on the number and percentage of total and diverse students served, progress made on objectives, sub-objectives, activities, and outcomes.

3. WHO IN THE SCHOOL DISTRICT IS SERVED?

Services will be provided to the Yonkers Public School (YPS) to meet the requirements of the RECOVS grant program.

Services will be provided by Interactive Health, LLC, founded in 1999, with expertise in school-based evaluation and research. Dr. Katherine Roberts, President of Interactive Health, who will oversee the services, is also an adjunct professor at Teachers College Columbia University, where she teaches Research Methods and Biostatistics.


