Dear Mr. Pavone:

We are pleased to provide a proposal for construction management services for the "Playground Upgrades" at School 15, 27, 28, 29 & Robert C. Dodson School, YPS #10956, 10953, 10954, 10955 & 10945. The upgrades relate to the contract documents being bid with 4 schools in one bid and one school in a separate bid. The architect is Fuller & D'Angelo Architects, P.C.. The services would be provided under Savin agreement 2022-00000600 from RFP-453.

The services to perform are the items listed in RFQ-453 under Article 4.2.f & g "Phase I - Pre-Construction Services" and all items under Article 4.2.1 "Phase II - Construction Management & Inspection Services" with the work performed by 1 contractor for each bid. The on-site services provide general observation services for compliance to contract documents, but do not include special inspections.

The bidding is progressing, and award will follow. The schedule for the construction phase is August 15, 2023 through November 15, 2023. Punchlist is to be completed December 30, 2023 and closeout January 31, 2024.

For the Construction Management services, we propose a lump sum fee of \$ \$93,750. A budget of \$12,500 is included for reimbursable/allowance. The total proposed amount is \$106,250. The fee form is attached.
