Dear Mr. Pavone,

We provide herewith our award recommendation letter for the above referenced project.

On Friday, May 3, 2024, bids were received from three (3) General Contractors and publicly opened. Overall, the bids received came within the project budget and, based upon the bids received from the bidders, the project can proceed.

In preparation for issuing this award recommendation letter, we conducted an evaluation of the apparent low bidder by calling the Bidder's references that were provided. Additionally, the project team convened an in-person interview with the apparent low bidder on May 13, 2023, at our office in White Plains, NY. The purpose of the interview was to review with them their proposal in detail, meet their project team, be assured of their full understanding of the contract documents and their scope of work as well as their understanding of the project goals and time frame.

Enclosed for reference is the attendance "sign-in" sheet from the in-person interview.

The project team had concerns regarding the contractor's understanding of the scope of work and requested follow up virtual meetings with the contractor and their subcontractor for the mercury abatement. At this meeting, held on May 21, 2024, it was determined that the contractor's bid proposal was incomplete and therefore deemed that the low bidder, RK Best Construction Inc. is a non-responsive bidder. Enclosed for reference is the attendance "sign-in" sheet from the virtual meeting.

A virtual interview meeting was then held on May 20, 2024, with the second lowest bidder, Abbott & Price, Inc. The purpose of this meeting was also to review the project scope in detail, their bid proposal and schedule requirements. It was determined upon the completion of this meeting that the contractor, Abbott & Price, has a clear and detailed understanding of project goals and schedule requirements. Enclosed for reference is the attendance "sign-in" sheet from the in-person interview.

On May 23, 2024, a follow up virtual meeting was held with Jim Hancrow of Abbott & Price Inc. together with a representative from Teal Management, their subcontractor for the mercury abatement. It was confirmed that Teal has the required experience, certification, full understanding of the procedural requirements and scope of work for the mercury abatement procedures. meet the required project schedule. Enclosed for reference is the attendance "sign-in" sheet from the virtual meeting.

General Construction Prime Contract

The following are the three (3) General Construction Prime Contract bids received:

Description	1 RK Best Construction Inc. (non-responsive bidder)	2 Abbott & Price, Inc.	3 Pierotti Corp.
Base Bid	\$614,014.14	\$885,808.00	\$916,500.00

Three (3) proposals were received on this contract with prices ranging from a low bid of \$614,014.14 to a high bid of \$916,500.00. The two lowest bids received, based on the base bid only, were within \$271,793.86 or 44.26% of each other and the third bidder was \$302,485.86 or 49.26% above the lowest bidder. All bidders provided the necessary bid security and acknowledged receipt of Addendum #1 and incorporated that information in their bids.

Of the three (3) low bidders, we have no prior experience with Abbott & Price, Inc. and RK Best Construction Inc. We do, however, have prior experience with Pierotti Corp. on public construction projects. In our review process, all the references called with regard to Abbott & Price, Inc. provided us with favorable evaluations, and all would utilize their services again.

As RK Best Construction Inc. was deemed to be a non-responsive bidder we hereby recommend to the City of Yonkers / Yonkers Public Schools that Abbott & Price, the second lowest bidder, be awarded the project. Therefore, we recommend the following:

• General Construction Prime Contract be awarded to Abbott & Price, Inc. in the base bid amount of \$885, 808.00.
