

## SCHEDULE "A" SCOPE OF SERVICES

### PURCHASE (3) THREE HOBART, OR EQUAL, SLICERS

**Intent:**

The following specification is to set forth the requirements to furnish and deliver the purchase of (3) Three Hobart HS7 Heavy Duty Automatic Slicer – 13" removable blade, or approved equal, slicers to the Yonkers Public Schools (YPS).

**Product Specifications:**

Products shall be ordered, furnished and delivered as identified by manufacturer, description, and/or model number on the Schedule "B" -- Itemized Bid Schedule of Prices.

In any cases where an item on the Itemized Bid Schedule of Prices is identified by a manufacturer's name, trade name, catalog number or reference, it is understood that the bidder proposes to furnish the item so identified and does not propose to furnish an "equal" **unless the proposed "equal" is definitely indicated therein by the bidder.** Bidders shall use the designated space on the Itemized Bid Schedule of Prices to identify alternate make and model for any proposed "equal".

All products must be readily available. In the event a product listed in the bid has been discontinued or otherwise is not available for delivery, bidders are encouraged to propose an "equal" product that is readily available.

Include technical literature with the bid submission to accompany any and all "equal" products. The City/YPS hereby reserves the right to approve as an equal, or to reject as not being equal, any article the bidder proposes to furnish which contains significant variations from specification requirements but may comply substantially therewith. Failure to include descriptive literature with the bid that is sufficient for the City's/YPS full evaluation of a proposed equal product may result in rejection of that product.

The City/YPS shall make the sole determination concerning whether bidder-proposed products are acceptable equals under the contract. These evaluations and decisions shall be completed prior to contract award. During the contract term, the successful bidder shall only deliver those items that were identified on the bid sheets. **PRODUCT SUBSTITUTIONS NOT PREVIOUSLY AUTHORIZED FOR DELIVERY WILL NOT BE ACCEPTED.**

**Warranty:** Vendor shall provide the warranty information on the equipment they are bidding.
