File Price End User Instructions

- (1) For Westchester County orders, end users shall contact the vendor for a price quotation. The vendor shall send end users (via e-mail or fax) a detailed quotation identifying the manufacturer, part number, part description, manufacturer's list price, quoted bid discount from manufacturer's list price, and final net price for each part. End users must attach this quote to the requisition and to the official Westchester County purchase order sent to the vendor via U.S. Mail or e-mail. No orders can be placed without vendor receipt of a purchase order.
- (2) When entering requisitions for this file price, end users must use commodity code 67055.
- (3) Category 3 orders from HD Supply Facility Maintenance and NY Replacement Parts are only for miscellaneous trade items and manufacturers not specifically included in Categories 1 and 2.

Delivery for all stock items is required within 5 days.

Delivery for all non-stock / special order items is required within 30 days. Minimum order: \$150.00
