This is to follow up the failure of an underground fuel tank tightness test on 8/31/2020 of tank # 1:

Luzon proposes to transfer the oil from the failed UST to other tanks in the district, Supply and install a 5,000 gallon AST for temporary fuel supply to the boilers, empty and clean the failed UST.

In addition, Luzon will provide a subsurface investigation in the area of the tank and a boring in the proposed area for the replacement tank.
