Rationale:	<p>NYSED requires all public school districts to complete the Fire Safety Inspections and staff training on a 11-month interval, although it is referred to as the "Annual" Fire Safety Inspection and applies to all 50 buildings that are owned, operated or leased by Yonkers Public Schools.</p> <p>CCI has performed this work effectively for the District intermittently since 2013. This contract provides a means to extend by mutual consent of the parties an additional year under the same terms and conditions as awarded.</p> <p>Original award was by Res 15.16 at the Feb. 26, 2020 meeting. This resolution is to extend the contract for a second year. The contract does not limit the number of extensions.</p>






