Rationale: This resolution is to assign Savin Engineers Pre-Construction

Management Services as per their response to RFQ453 on 29 capital projects that are at various stages of design with a total value of

approximately \$115 million.

Savin will be assisting School Facilities in performing constructability reviews and cost estimates to limit change orders and delays by ensuring that all aspects of scope of work are fully covered, making recommendations for materials and equipment to limit long lead problems and assist in planning, scheduling and preparing bids to meet construction milestones. This is to be done on an as needed basis at the direction of the department. Payment is based on the terms and conditions in Contract 2022-0660. The projects and the associated funding are listed on the attached spreadsheet.
