The Roger portfolio consists of several products – microphones, speakers and receivers – all exclusive to the Phonak Brand. Sonova USA Inc. ("Sonova USA") is the sole US wholesaler for Roger products. Sonova USA sells Roger products to dispensers and other distributors for resale for patients' use in their personal or professional lives.

Phonak Roger microphones are the only product that automatically and adaptively measure the noise in a classroom and communicate to the hearing instrument through the Roger receivers. This increases the advantage over a hearing instrument's environmental microphone and maintains a very positive signal to noise ratio — which is critical for children to learn. This Roger technology provides best speech-in-noise performance and documented improvements of up to 35% over Dynamic FM and 54% over other FM systems¹.

Roger Touchscreen microphones are the only synthesized microphones available that have monitoring and voice activity detector technologies. It can be worn by a teacher in lanyard mode, be placed on a table for Small Group Mode, or used in pointing mode. Additionally, this microphone can be used for remote learning. This microphone will work in a network with up to 35 other Roger microphones and unlimited receivers.

Roger Pass-around Microphones are designed for use in classrooms; these devices might be referred to as 'peer microphones'. Phonak Roger On™, Roger Select™, Roger Table Mic II and Roger Clip On mic are other cutting-edge wireless microphones. Like their Roger for Education counterparts mentioned previously, they are adaptive and work with almost any manufacturer's hearing instruments. However, these microphones only work with each other in a MultiTalker network, so they cannot pair with a Touchscreen Mic or a SoundField system, for example. Nonetheless, when placed on a table, the Roger On, Select or Table Mic II automatically select the person who is talking and seamlessly switches from one talker to another.

Roger receivers consist of Roger X, Roger 14, 17, 18, 19, 20 and 21. They are compatible with virtually every hearing instrument and cochlear implant speech processor on the market.

A Roger Focus II is a discrete behind-the-ear Roger receiver for children with normal hearing who require help focusing on auditory stimuli. Common use cases are for children with Unilateral Hearing Loss, Auditory Processing Disorder or have Autism. There is no other solution like this currently offered. Both a battery powered and a rechargeable device are available.

A Roger NeckLoop is a universal inductive neckloop receiver. Schools may choose to use it for non-traditional applications such as automated speech-to-text for students who don't need CART but would benefit from automated captions. Additionally, a NeckLoop can be connected to a teacher's computer to facilitate improved listening during synchronous, remote learning sessions.
