



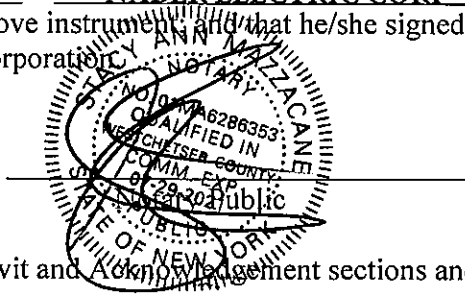

CONTRACT AWARD:

The contents of this addendum alter and amend the original Bid requirements and take precedence over the related items therein. This addendum forms a part of the contract documents. Bidders must acknowledge receipt of all addenda when submitting their bids. Failure to acknowledge receipt may render your bid non-responsive and ineligible for award.

PLEASE NOTE THE FOLLOWING:

I. Response to CLARIFICATIONS/RFI's:

- 1- Question: Please confirm only window shades are required in shop level new window locations.
Response: Correct. Provide shades at new windows on Shop Level. Cafeteria windows are existing.
- 2- Question: Please confirm existing plaza deck slab is 3-inches thick.
Response: Thickness is as shown on original construction documents
- 3- Question: What is the current load rating at the plaza deck.
Response: This is not known.
- 4- Question: DWG A100, notes 4 and 8 state to remove existing exhaust hood and duck/louwer. Demolition of this work is also included on M-201. Please confirm this work is part of HVAC contractor scope
Response: Demolition of the hoods, ducts and louvers are a part of the work of the Mechanical Contract. However, all rough patching, firestopping and finish patching shall be by the General Contractor
- 5- Question: Please provide specification for bridge expansion joint system.
Response: Expansion joint system shall be EMSEAL DSM, or equal. (See attached literature)
- 6- Question: During the pre-bid, it was noted this project is to start in September. Please advise if this work can be performed during normal working hours and which items must be performed at second shift.
Response: If awarded today the work (during the summer) can work day or first shift. However once the school returns (in September) work will be limited to second shift. Only exception would be if the school agrees to allow some day work, but you cannot plan that way.

- 7- Question: Detail 6 on DWG A801 for gypsum soffit is not shown on any drawings. Please confirm this is not included in the scope.
Response: Detail 2, Sheet A801 was intended to show the location of the soffit, but did not print. The soffit is along the corridor wall in Rooms 2003A and 2005. It will conceal the ducts shown on Drawing 2, Sheet M-202. The length of the soffit is approximately 50 LF.
- 8- Question: Finish schedule on A801 shows new VCT.
Response: Correct.
- 9- Question: Details 1, 2 & 3 on A035 call for 60 PSI polyiso insulation. This product does not exist. Specification 072100 calls for extruded polystyrene board under concrete slabs. Please confirm that the plaza gets 60 PSI extruded insulation and not polyiso as shown.
Response: Provide 60 PSI EPS Insulation as specified.
- 10- Question: If the existing slab is sloped per detail 1 on A035 would the contractor be responsible for sloping the insulation? Assuming some “tapering” may be required at the scuppers.
Response: The Contractor is required to slope the system to the scuppers.
- 11- Question: Specifications call for both single and double shades but does not indicate which type go where. Please clarify.
Response: Single shades are to be provided at the classrooms.
- 12- Question: Please clarify the waterproofing scope and specifications for the Arena Plaza on A031. Details on A035 call for a 2-ply waterproofing sheet, but 071400 calls for a fluid-applied waterproofing system. 071400 also does not provide a specification for the liquid-applied product, or a basis of design.
Response: Provide 2 Ply Sheet Waterproofing as per attached Section 07 1150.
- 13- Question: There is a conflict between details 1, 2 & 3 on A035. Detail 3 calls for new fill/screed, while details 1 & 2 call to patch/repair the existing. Is there an existing sloped topping slab? Is the contractor only required to patch existing deck as needed for the waterproofing scope?
Response: Contractor shall remove existing assembly to the structural deck and provide new fill/screed to achieve pitch to the drains.
- 14- Question: The specs clearly show quantities of asbestos flooring and asbestos sinks. However, the plans (drawing HM-100) do not show the quantities of asbestos with reference to chalkboards, insulation, vapor barrier, sheet rock, and pipe fittings. Please advise.
Response: As for the quantities for the walls, there is a scale noted on the drawing. It is up to the bidders to do a walk-through and field verify, as noted in the general notes. Chalkboards do not get quantified typically. We show locations of the items. The specific boards being removed are labeled as such. For instance, the ones in Rooms 2003 and 2005. Boards which are not being removed do not have any symbols, such as the one in Room 2007.

Asbestos fitting quantities are on the drawing in a hexagon symbol. For instance, there are 2 in Room 2005A (at ceiling level if I recall correctly), and there are 10 listed in Room 1004B.

The vapor barrier in the exterior wall is assumed to be there. The quantity of each opening would be whatever is specified for the opening by the Architect. If no vapor barrier is found, then the GC may cut out the remaining windows and a credit can be received from the abatement contractor.

15- Question: Detail 6/A035 is missing, please advise

Response: Where reference is made to Detail 6/A035, Contractors shall refer to Detail 2/A035

16- Question: On drawing #A101 there is a window designated as RW (n). Is this a new window? Please advise.

Response: Yes. New Rescue Windows are shown in plan on 1/A101 and 2/A101; in elevation on 1A/200 and 1B/A20; and in detail on 2/A820 and 4/A820.

SCHEDULE "C"

CERTIFICATION REGARDING BUSINESS DEALINGS WITH NORTHERN IRELAND

- A. The Contractor and any individual or legal entity in which the Contractor holds a ten percent (10%) or greater ownership interest and any individual or legal entity that holds a ten percent (10%) or greater ownership interest in the Contractor (a) has no business operations in Northern Ireland, or (b) shall take lawful steps in good faith to conduct any business operations in Northern Ireland in accordance with the MacBride Principles.
- B. For purposes of this Certification, "MacBride Principles" shall mean those principles relating to nondiscrimination in employment and freedom of workplace opportunity which require employers doing business in Northern Ireland to:
- (1) increase the representation of individuals from underrepresented religious groups in the work force, including managerial, supervisory, administrative, clerical and technical jobs;
 - (2) take steps to promote adequate security for the protection of employees from underrepresented religious groups both at the workplace and while traveling to and from work;
 - (3) ban provocative religious or political emblems from the workplace;

- C. For purposes of this Certification, "Northern Ireland" shall be understood to be the six counties partitioned from the Irish Province of Ulster, and administered from London and/or from Stormont.
- D. The Contractor agrees that the warranties and representation in paragraph "A" are material conditions of this Contract. If the City receives information that the Contractor is in violation of paragraph "A", the City shall review such information and give the Contractor opportunity to respond. If the City finds that such a violation has occurred, the City may declare the Contractor in default, and/or terminate this Contract. In the event of any such termination, the City may procure the supplies, services or work from another source in accordance with applicable law. The Contractor shall pay to the City the difference between the contract price for the uncompleted portion of this Contract and the cost to the City of completing performance of this Contract either by itself or by engaging another contractor. If this is a contract other than a construction contract, the Contractor shall be liable for the difference in price if the cost of procurement from another source is greater than what the City would have paid the Contractor plus any reasonable costs the City incurs in any new procurement and if this is a construction contract, the City shall also have the right to hold the Contractor in partial or total default in accordance with the default provisions of this Contract. In addition, the Contractor may be declared not to be a responsible bidder or proposer for up to three (3) years, following written notice to the Contractor, giving the Contractor the opportunity for a hearing at which the Contractor may be represented by counsel. The rights and remedies of the City hereunder shall be in addition to, and not in lieu of, any rights and remedies the City has pursuant to this Contract or by operation of law or in equity.

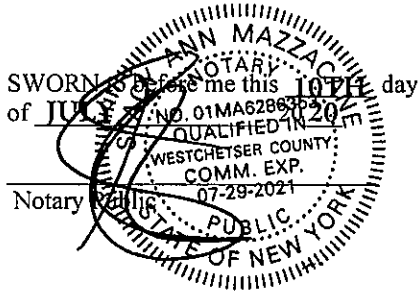



During the term of the Contract, should the City of Yonkers receive information that a Bidder/Contractor is in violation of the above-referenced certification, the City will offer the person or entity an opportunity to respond. 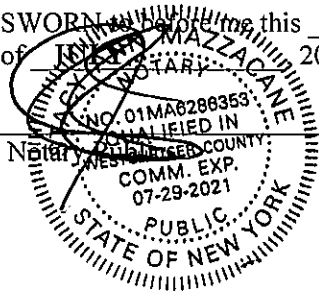



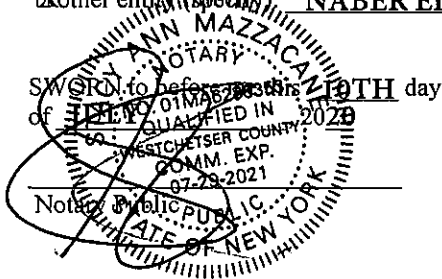
