Bids for RFB -6328 were publically advertised, received and opened on November 9, 2018. Only one bid was received and reviewed. This year's award is \$9,970.00 less than last year's contract due to a reduction in estimated amount of repair work that will be required on the trucks.

H&C Truck Repair was the sole bidder, however they have won this contract in the past through competitive bidding and have performed **Rationale:** acceptably. This latest bid is in line with the prices bid for this work in

the past. Last year's contract was awarded for \$90,000.00, out of which \$85,300.00 has been expensed to date. The contract expires on

11/29/2018.
