The staff members will engage in individual and facilitated small group sessions to identify and reflect on effective practices in order to drive continuous improvement in their instruction.

The contract will consist of 10 days of professional development to include training and coaching. Services will be provided at the Andrus Orchard School in Yonkers, NY.
