Scope of work includes:

- (54) 3-0 x 7-0 SGLS & (12) 6-0 x7-0 Pairs (24) Leaves- Total of 78 Leaves and all associated hardware
- All Fire Rated Hollow Metal Doors Priced as Curries 707 series (As per specs)
- All Doors figured with NGP L-FRA100 Vision Kits
- All Vision glass figured as TGP 3/16 FireLite NT (Superlite equivalent)
- All hardware finishes will be Satin chrome/Stainless steel (All hardware per District specs)
- Paint selected by District (Factory Finish)

Exclusions / Conditions

- Pricing based upon bid "Bay Shore UFSD General Building Maintenance involving New Construction, Reconstruction, and Demolition."
- Final billing determined on actual usage. Back up for all costs provided at time of billing.
- Excludes Hollow Metal Frames. All Frames Existing to remain.
- Excludes Door Elevation D-2; Elevation D-2 figured as 24x30 Half -Lit Vision in lieu of 3-Lite cutout
- Excludes Floor Mounted Door Closers. Heavy Duty Non-Hold Open Parallel Arm Closers figured only.
- Excludes ALL Electrical Hardware: EPT's, Door Loops, wires, electric strikes, transmitters, card readers, motion sensors, power supply, etc.
- Mechanical, electrical, plumbing, or fire alarm work of any kind is <u>not</u> included.
- Roof flashing and penetrations of any kind are <u>not</u> included.
- Abatement of any kind is <u>not</u> included.
- Owner is responsible to verify hazardous material will not be impacted by the proposed work.
- Customer responsible for SED/ Code Compliance.
- Customer acknowledges subcontractors may be utilized.

- Work is limited to scope and quantities expressly listed in proposal; not specifications or special provisions are included.
