Scope of Services

The scope of work for this project is to enhance the building's security by supplying parts and smart for cameras, access control, ILDA's and burglar alarm system for **YMHS**

This scope includes devices to be given to the GC/EC - exterior cameras and mount, interior IP Cameras/Mounts, Access Control Readers, ILDA's, burglar alarm system with Motion Detectors, Door Contacts, network video recorder, display monitor, video workstation with monitor, ~~parking gates~~, POE switches, port patch panels, access control panel and sirens to match and work with the City's existing Ccure-9000/Victor Video unification platform. This work is in alignment with COY existing platform Software House Ccure-9000, American Dynamic's Victor and other sub-systems such as IP based video intercoms, PLC/Touch screen controls and others. This work will be programmed and added to Victor Unified System including utilization of maps and events.

EC to install (as per manufacturer's instructions,) terminate and provide assistance at time of test and commissioning. EC to provide all wire, conduit and any other rough material as needed. EC to certify all cabling to verify proper installation and terminations. All certifications to be provided to ITG and BOE prior of commissioning of system.

ITG Larson to provide all equipment. ITG to provide project management throughout project. Burglar alarm system to be programmed and tested to their respected central station monitoring station by others.

ITG will prefabricate, program and pre-test all equipment prior to arriving on site in order to minimize downtime and increase efficiency. ITG will also field program certain items as needed. As this system is highly computerized, ITG will also manage all aspects of the networking IP schema needed for this project and will coordinate with owner's IT group as needed. - Working with and coordinate with COY-IT for IP addresses and Cisco routing (YPD, YPA, YPL,YFD, BOE are on separate networks, and may have duplicate IP addresses)
- Work with COY-HR to build user’s access rights, time code, user rights, holiday schedules etc.
- Program Ccure Personnel Database to match HR project specific instructions
- Work with COY-IT for ePersonality and Ceridian HR nightly interfaces
- Where needed, work with COY vendors to get the various Burglar panels to integrate with CC 9000 as to provide unified view
- Create alarm events for things such as: panel offline, PS failure, reader offline etc.
- Work with various sub-manufacturers to develop needed API/DLL
- Create Victor-Camera integration for automatic alarm call up as needed
- Build up site specific maps and icons, lay on the COY Platform - Master
- Create Dynamic active Icons and events
- Meet with Police and assure pertinent images/configurations are available
- Provide end user and Police/IT Training
- Provide one year on-site warranty and deal with defective items

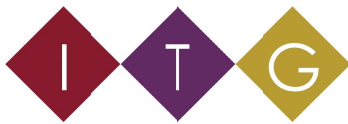

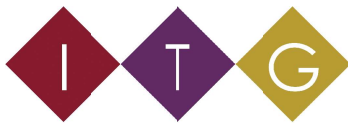
