Dear Lee,

It is with great pleasure that we submit our proposal for professional architecture and engineering services to Yonkers Public Schools for **RFP**; **420-25-01**. We take great pride in submitting this proposal and continuing our relationship with Yonkers Public Schools and the School Facilities Management team.

For the above referenced RFP, we will utilize the team identified in our On-Call AE Service agreement that includes **Barile Gallagher & Associates** for MEP/FP, **Reilly Tarantino** for structural engineering, and **Bohler Engineering** for Site/Civil design and engineering.

Our understanding of the scope of services for School 23, Family School 32, and Enrico Fermi School includes:

- Investigation of deteriorating stairs, landings and ceilings at entrances.
- Interior and exterior restorative design of entrances and entrance vestibules, and lighting where applicable.
- Structural repairs, water proofing, abatement, and restoration of adjacent finishes, including railings where applicable.

Restorative design of finishes and lighting, fire alarm and plumbing is also included in the scope of services at School 23. And, Family School 32 will include the replacement of corroded electrical conduit and back boxes, and new hangers and supports for both electrical conduit and HVAC piping in the vicinity of the crawlspace below the main entrance.

The scope of services at Lincoln Hight School includes the replacement of the existing concrete stair at the south end of the building.

The proposed estimated budgets seem to be appropriate for the identified scope of work however, from previous YPS projects, we have found the budgets to be lower than milestone estimates. As a project team, we will work together to align scope and budget. We understand that the projects are to be designed and submitted to SED as part of this proposal, but bidding and construction administration are not.

Thank you for this opportunity, we look forward to working together again.

The concrete stairs to be replaced are the stairs at the south end of the building allowing travel from the Staff Parking lot to the Ground Floor Shop Classroom egress area.

The consultant will be required to perform the structural investigations and designs for the repairs to the concrete columns supporting the overhanging saw-toothed classrooms.
