Rationale: By Resolution 18.11 dated May 18, 2022 the Board of Education authorized PO 2023-0465 for the provision of \$150,000.00 to City of Yonkers Contract 2022-0777 "2022 Public Right of Way Improvements" for the District to "piggyback" onto their contract to make site improvements throughout the District.

This is to provide an additional \$200,000 in funds to increase the scope of work.

The City DPW awarded Paladino Concrete Creations Corp. a \$1million contract to perform city wide right of way improvements in April of 2022.




