**Rationale:** By Board Resolution Item 18.5 dated July 21, 2021, Contract 2022-0188, "On-Call" Electrical Repair Services, was awarded to Scotty Electric Corp. for \$97,070.00 and 365 calendar days. It is noted that the City of Yonkers has increased the contract \$16,989.40 using City funds. The revised contract amount is now \$114,059.40.

The terms and conditions provide for annual renewal for up to five years by mutual consent of the parties under the same terms and conditions as originally awarded.

This resolution is to invoke the renewal clause, extend the contract term to 730 calendar days and funding for another year. The revised contract amount including the City funding will be \$211,129.40.

This is a general fund annual service contract for electrical work that is beyond in-house capabilities.




