

PERFORMANCE BASED CONTRACT GUIDELINES

1. WHAT IS THE PURPOSE AND SCOPE OF THE SERVICE? (Describe in detail any services to be provided or materials to be purchased)

1. Interactive Health, LLC will provide evaluation services pertaining to the implementation of the Extended School Day/School Violence Prevention (ESD/SVP) Program as well as the McKinney-Vento Grant Program. For the ESD/SVP, Interactive Health, LLC will review all partner activities, attendance data, teacher PD and student satisfaction survey data; will administer a partner survey; analyze and report data on the quality of the program; provide branding ideas to improve school environment; meet with Project Director to review data; and assist in completing grant-related reporting. For the McKinney-Vento program, Interactive Health will provide reporting and evaluation of programmatic interventions focused on McKinney-Vento students in order to inform future refinements to programming. Interactive Health, LLC will also assist with preparing grant reports and documents for both programs.
2. Interactive Health, LLC will provide services pertaining to the implementation of the My Brother's Keeper Family and Community Engagement Program (MBK FCEPS) Grant. Interactive Health, LLC will provide the district team with consultation related to the re-evaluation and rewriting of the district-wide Family and Community Engagement Policy. Interactive Health, LLC will also work with the grant management team on assessment activities.

2. AMOUNT OF SERVICE?

Chavez, and MLK. Interactive Health will provide 6.7 days pertaining to the McKinney-Vento Grant Program held throughout the district. Interactive Health will provide 22.2 days pertaining to the MBK FCEPS grant throughout the Yonkers Public School (YPS) District.


