Rationale:

Change Order 1 to Contract 2022-0796 "Service and Repair of Electric Motors & Pumps" with A&C Furia for \$50,000.00 with no change in term increasing the contract from \$22,125 to \$72,125. There is a large percentage of failing pumps and motors that have been repaired repeatedly and are now beyond that option. This is a time and materials based contract. The initial quantities included for bidding purposes have proven insufficient for the current needs of the District. All of the work is being done at the contract bid prices.
