> RESTORATION" CIP 10862 School 14 Modular, CIP 10863 School 23 & CIP 10866 Riverside High School to MILCON Construction Corp. for

\$3,406,670.00 and a term of 365 calendar days.

Construction contract IFB 6606, General Construction Contract work, "Group A Building Envelope Restoration", in compliance with General Municipal Law 103, was let for public bid and bids were opened in public and read aloud on April 23, 2021. A total of Six (6) bids were received, with the highest bidder at \$5,664,636.00 the average at \$4,704,036.

A-1 Construction Services, the apparent low bidder at the bid opening, was determined to be non-responsive in that they did meet the experience and sought to sub-contract more of the work than

was specified and was therefore disqualified.

The work was designed by KG&D Architects and was estimated to be approximately \$4,887.000. KG&D will also be doing the

construction management.
