RE: Request for Emergency Declaration
Procurement of Goods and Services for COVID-19 Response

I have approved the amended Request for Emergency Declaration from Executive Director John P. Carr to increase the total amount from \$3M to \$5M. The first Emergency Declaration was dated July 27, 2020, amended on August 24, 2020, to increase the amount from \$1M to \$2M and again on October 7, 2020, to increase the amount from \$2M to \$3M. Due to the continuation of COVID-19 and keeping in compliance to meet the requirements and/or recommendations made by NYSED, NYSDOH, and the Governor's office promulgated in mid-July that the district must be able to procure goods and services at an accelerated rate to meet the COVID-19 health crisis, I am requesting a third amendment to increase the total amount from \$3M to \$5M.

The new anticipated expenses to date are approaching \$3M. Therefore, at this time the upper limit is asked to be increased to \$5M to be used for procurement under GML104b in lieu of GML103 to continue to meet this emergency.

Thank you for your cooperation and consideration of this request.


Anticipated expenses to date are approaching \$3,000,000 (in rough numbers):

- HVAC contractors \$2,500,000
- Plumbing contractors \$210,000
- Electrical contractors \$400,000
- Hardware \$350,000
- General Construction \$400,000

At this time the upper limit is asked to be increased to \$5,000,000 to be used to for continued procurement under GML104b in lieu of GML103 to continue to meet this emergency.
