**TERMS AND CONDITIONS:** Premier Business Solutions, Inc. (PBS) will provide service and maintenance on covered equipment listed below. The number of service requests allowed is unlimited. *The service to be rendered does not cover repairs required because of accident, fire, water, abuse, operator error, nor does it cover changes in set-up or burned-out motors. Costs associated with cosmetic appearance of equipment, floor covering, fluorescent lights or fixtures, expendable parts, and carrier trays are not covered.* In the event the machine(s) requires overhauling or rebuilding, an estimate will be submitted for customer's approval before the work is started. Hours of operation for coverage are 8:30 AM to 5:00 PM, Monday through Friday, except holidays. Charges for service required on an overtime basis will be charged for at the prevailing overtime repair rate. Only factory authorized parts shall be used as replacement parts. Only PBS factory trained technicians shall provide service. All prices quoted are based on the understanding that all equipment will be used on a standard work day of one shift per day, five days per week. Where a two or three shift operation is used, the prices reflect the higher rates. If equipment under contract is relocated, changed or altered in any way not by PBS personnel, this agreement is suspended. PBS reserves the right to examine equipment prior to accepting a maintenance contract. Preventive maintenance will be completed on equipment bi-annually. **IN NO EVENT shall PBS be liable for any special, indirect, consequential, or exemplary damages including, without limitation, loss of anticipated profits or business opportunities, for specific performance.** This agreement is subject to cancellation by either party with a 30 day written notice.
