Historical and Cultural Context: Exploring the connection between the Civil Rights Movement and the rise of breakdancing as an artistic and cultural expression that brought young people, especially of color, together and gave them a voice.

Music and Breakdancing: Professional videos, music, and possible live demonstrations to show how breakdancing has not only shaped London's life but also played a significant role in global entertainment.

Interactive Engagement: Opportunities for students to reflect on how they can apply the lessons of resilience, mentorship, and the power of art to their own lives.
