Rationale: By Resolution 17.6 dated August 17, 2022 the Board of Trustees

authorized the Superintendent of Schools to enter into a lease agreement with I.PARK RIVERDALE LLC, as landlord for the Ames and Biondi buildings that comprise the Biondi Education Center School on the campus of 401 Hawthorne Avenue at \$200,000.00 per month, \$2,4000,000.00 per annum, and increase at a rate of 2.5%

per year.

This is to amend the agreement due to changed national economic

conditions to increase the monthly rent to \$250,000.00,

\$3,000,000.00 annually, increasing at a rate of 2.5% annually. This lease will be eligible for State Education building aid. Occupancy and

rent commencement are targeted for the fall of 2024.
